4. Sealed bids must be submitted to the office Bode Barsain Municipality, Saptari *by hand on or before the specified date and time as shown in below table*. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at the specified date and time as shown in Table below at the office of Bode Barsain Municipality, Saptari. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of as shown in table below, which shall be valid for 30 days beyond the validity period of the bid (i.e.75days).
6.
